LAS VERDES MEETING MINUTES

Las Verdes POA meeting March 11,2025

The meeting was called to order by President Thomas Massey

A motion to waive the reading of the minutes from the last meeting was made by Jack Walsh and 2^{nd} by Bobbie Bruno.

Treasurer's Report

- Cash-in operating \$1,511,445.11
- Funds in reserves \$1,415,960.35.
- Total operating and reserve funds \$2,572,428.94
- Delinquencies. \$40,296

Motion to accept the treasurer's report as read: motion by Bobbie Bruno seconded by James Fogarty motion was approved.

President's report: We really do not have anything new to discuss at this meeting tonight.. The changes made out front have been completed and the issues with the phone out at the guard shack has been resolved thank you Willie for getting that resolved. We are discussing replacing the gates on Military Trail and the Linton Boulevard entrance. The gates are getting old. We keep piecing them together. New gates will cost approximately \$6,000 each so we think we're going to just do all four gates at once. Motion to accept the President's report was made by Jim Fogarty 2nd by Bobbi Bruno .

New Business: We are going to remove the shuffleboard game at the viburnum pool, which is pool number 2 we are planning on putting in a concrete pad and we're tossing around different ideas, maybe erecting a tiki hut structure like we have at the clubhouse pool they're easy to maintain. They

cost less to construct versus doing the canvas covering like we have at the other pools those fade out where the tiki hut really is maintenance free. The purpose of putting in this pad with the covering is so people will have a place to go eat and socialize. The other two pools have outside areas and we feel they should all be equal. We are getting estimates we're looking at \$50-\$60,000 for the concrete pad and sitting area. We will not act on anything until we get the estimates and then we have it approved by the board.

We have one more large pipe. It is a 60 inch pipe that runs from copper leaf to the Main Pond. We're waiting on the proposal for that but the pipes are going to be an ongoing project because we have smaller ones we will work on.

Motion to accept Jack Walsh 2nd by Bobby Bruno.







To Register:

- Go to Portal
- Click Sign In
- It will take you to login page, click Create Account.
- Make sure to include the Account Number and/or property address.
- After you register, the management office has to approve your registration. Once approved you will receive an email to change your password.

If you have more than one account:

- Click on your name on the top right corner
- Click on Switch Accounts
- Scroll down click on Register Additional Property
- If you need to switch accounts just do steps 1-3 to select the account you want to access.

To View Payment History:

Your Account Balance shows up on your dashboard.
